



GENERAL TERMS OF USE

Companyofgood.sg

Thank you for visiting the Company of Good Web site (at the domain name Companyofgood.sg) (this "Site"), which is maintained by the National Volunteer & Philanthropy Centre ("NVPC", "we" or "our"). "You" or "your" refers to any such party who is given access to or use of the Site and/or Services (defined below) by NVPC.

The following terms and conditions govern your access and use of the Site and the Services (defined below). By accessing and using any part of this Site and/or Services, you are indicating your agreement to be bound by the following terms and conditions of use ("Terms of Use"). If you do not agree to all the terms and conditions of these Terms of Use, please do not access or use this Site or any of its Services.

These Terms of Use are current as of **30th June 2016**

Access to and use of password-protected and/or secure areas of the Site and using the Services are restricted to Members (defined below) only. You may not obtain or attempt to obtain unauthorised access to such parts of this Site and/or Services, or to any other protected information, through any means not intentionally made available by us for your specific use. A breach of this provision may be an offence under the Computer Misuse and Cybersecurity Act (Cap. 50A) of Singapore.

If you are below 18 years old: you must obtain consent from your parent(s) or legal guardian(s), their acceptance of these Terms of Use and their agreement to take responsibility for: (i) your actions; (ii) any charges associated with your use of any of the Services, software or content provided or purchase of goods; and (iii) your acceptance and compliance with these Terms of Use. If you do not have consent from your parent(s) or legal guardian(s), you must stop using/accessing the Site and using the Services.

DEFINITIONS

1. "**Materials**" means, collectively, all content, information, functionalities, services or materials displayed, provided or made available on the Site or through the provision of the Services, including but not limited to text, software, code, scripts, webpages, music, sound, photographs, video, graphics, graphical user interface, forms, diagrams, toolkits, training materials or other material contained in the Site.
2. "**Member**" means a registered user of a Company of Good account at the Site.
3. "**Personal Data**" means any data about an individual from which can be identified, either (a) from that data; or (b) from that data and other information to which we have or are likely to have access, including data in our records as may be updated from time to time. Examples of such Personal Data include but are not limited to your name, NRIC, passport or other identification number, personal telephone number(s), personal mailing address, personal email address, personal bank account, credit card information, employment history, education background, income levels.
4. "**Services**" means services, information and functions made available by us through the Site.



RIGHTS OF ACCESS

5. This Site is an official NVPC Web site and is owned and operated by NVPC.
6. You agree to comply with all guidelines, notices, operating rules, policies and instructions pertaining to the access and use of the Site, Services and/or any Materials, as issued by NVPC from time to time. NVPC reserves the right to revise or amend these guidelines, notices, operating rules, policies and instructions, including these Terms of Use, at any time in its sole discretion and you are deemed to be aware of and bound by any changes to the foregoing upon their publication on the Site. You can determine when these Terms of Use were last revised by referring to the preamble above. You agree that the amended version of these guidelines, notices, operating rules, policies and instructions (including these Terms of Use) shall apply to you if you access or use the Site and/or the Services after such amendments have been made, and you shall be deemed to have consented to such amendments. CREATING A COMPANY OF GOOD ACCOUNT

12. NVPC approval for a Company of Good account, if given, will be given at NVPC's sole discretion and on the basis of the information furnished or purported to be furnished in the application form by the company named in the form and any other information subsequently furnished or purported to be furnished relating to the use of Company of Good, whether directly to NVPC or via Company of Good.
13. A user name and password may either be: (i) determined and issued to you by NVPC; or (ii) provided by you and accepted by NVPC in its sole and absolute discretion in connection with the access and use of the Site and/or Services. NVPC may at any time in its absolute discretion forthwith invalidate the user name and/or password, or your Company of Good account without giving any reason or prior notice, and shall not be liable or responsible for any loss or damage suffered by or caused to you or arising out of or in connection with or by reason of such invalidation. You hereby agree to change your password from time to time and to keep the user name and password confidential and shall be responsible for the security of your Company of Good account and liable for any disclosure or use (whether such use is authorised or not) of the user name and/or password. You are to notify NVPC immediately if you have knowledge that or have reason for suspecting that the confidentiality of the user name and/or password has been compromised or if there has been any unauthorised use of the user name and/or password.
14. You agree and acknowledge that any access and/or use of the Site and/or Services and any information, data or communications referable to your user name and password shall be deemed to be, as the case may be:
 - a. access and/or use of the Site and/or Services by you; or
 - b. information, data or communications posted, transmitted and validly issued by you.
15. You agree to be bound by any access and/or use of the Site and/or Services (whether such access or use is authorised by you or not) and you agree that NVPC shall be entitled (but not obliged) to act upon, rely on or hold you solely responsible and liable in respect thereof as if the same were carried out or transmitted by you. Each Member agrees that it shall not modify the Member Materials without our written approval and that we or the relevant copyright owners retain all copyright and other proprietary notices contained in the Member Materials.
17. Any request to use, reproduce, publish or transmit any Member Materials for commercial purposes in any form or by any means, electronic, mechanical, photocopying, recording, or

18. 19. **Restricted use:** No part or parts of any NVPC IPR may be reproduced, reverse engineered, decompiled, disassembled, separated, altered, distributed, republished, displayed, broadcast, hyperlinked, mirrored, framed, transferred or transmitted in any manner or by any means or stored in an information retrieval system or installed on any servers, system or equipment without our prior written permission or that of the relevant copyright owners. 24. All information furnished or purported to be furnished in an application for a Company of Good Account, and any other information subsequently furnished or purported to be furnished in relation to the access and use of the Site and/or the Services, whether directly to NVPC or via Company of Good, including any information, text, graphics, photographs or other materials submitted by any user (including you) through the Site and/or Services (collectively the **"Submitted Data"**) will be used by NVPC subject to the NVPC Privacy Policy.
25. You warrant and represent that you have the right and authority to submit the Submitted Data (including any confidential information as part of that Submitted Data) and that such Submitted Data does not infringe the intellectual property rights or any other rights of any third party. You hereby grant (and/or (if applicable) warrant that you have procured from all relevant third parties the right to grant) to NVPC a non-exclusive, world-wide, royalty-free, irrevocable licence and right to collect, use, disclose, host, transmit, exploit and distribute (which will include without limitation the right to copy, reproduce and/or publish) your Submitted Data in connection with your Company of Good membership and/or the provision of the Site and the Services to you and to all other users. You warrant that NVPC's use of your Submitted Data in this manner does not cause you or your employer or client to breach any duty of confidentiality, secrecy, fiduciary duty, contractual obligation, or any applicable laws or other legal requirements.

28. To the fullest extent permitted by law, NVPC does not warrant and disclaims any and all other warranties, whether express or implied, including but not limited to:

TERMINATION

32. 37. If any provision of these Terms of Use is held to be invalid, illegal or unenforceable (whether in whole or in part), such provision shall be struck and severed from these Terms of Use and the remaining provisions of these Terms of Use shall not be affected thereby.
38. No failure or delay by NVPC to exercise its rights under these Terms of Use shall operate as a waiver thereof nor shall such failure or delay affect its right to enforce its rights under these Terms of Use.
39. If these Terms of Use are translated into a language other than English, the English text shall prevail.
40. No person or entity who is not a party to these Terms of Use shall have any right under the Contracts (Rights of Third Parties) Act (Cap. 53B) of Singapore or other similar laws to enforce any term of these Terms of Use, regardless of whether such person or entity has been identified by name, as a member of a class or as answering a particular description. For the avoidance of doubt, this shall not affect the rights of any permitted assignee or transferee of these Terms of Use.
